1.11.4 The IFPS re-addressing function	1.11.4
1.11.4.1 The IFPS is unable to calculate any addresses for the VFR or OAT portion of a flight within the IFPS zone, as well as for the entire portion outside the IFPS zone of any type of flight. The flight plan message originator is responsible to address the message to all those ATS units concerned by such a portion of the flight. In order to have the same IFPS validated message being distributed to all addressees concerned, the so called IFPS readdressing function shall be used.	1.11.4.1
1.11.4.2 Any additional addresses to be included shall be placed after the date/time - originator group line and immediately before the open bracket which indicates the beginning of the message.	1.11.4.2
1.11.4.3 The IFPS will, after successful processing, disseminate the message to the extra addresses in addition to the calculated addresses within the IFPS zone.	1.11.4.3

1.11.4.4 Any existing AO address or addresses of handling agents may therefore also be included in the extra address lines.

1.11.4.5 The following rules apply:

- As many extra address lines as needed may be created.
- •• Every extra address line must begin with the keyword 'AD'.
- •• The extra address lines must be consecutive (no other comment lines between them), and they must be immediately before the line containing the open bracket.
- •• There must be no more than 7 addresses per line, and each must be of 8 characters.
- 1.11.4.6 When the IFPS re-addressing method was applied for the addressing of a Flight PLan (FPL), the following associated messages (i.e. CHG, DLA, CNL) related to the same flight need only to be addressed to both IFPS addresses. The IFPS, having stored the complete address list of the original flight plan will disseminate the modified data accordingly.
- 1.11.4.7 Associated messages related to a RPL in contrary need always to have the extra address lines included, if § 1.11.4.1 applies, as no previous reception of a flight plan containing such addresses occurred at IFPS.

1.11.5 Addressing of flight plan and related messages for flights into or from the IFPS zone

- 1.11.5.1 Aerodrome of departure within aerodrome of destination outside the IFPS zone
- 1.11.5.2 For that portion of the flight within the IFPS zone, the two IFPS addresses according to § 1.11.1.1 are to put in the addressline of the message; and, supplied in the extra address line(s) according to § 1.11.4, the addresses of all appropriate ATS units outside the IFPS zone in accordance with ICAO procedures and as published in the AIPs of the States concerned.
